1. NEW SEASON FEES & PAYMENTS

1A. Player Fees

Seasonal Player Fee: \$55

- **\$25 Scorekeeper Fee** — increased from \$20
- \$20 BCA Sanction Fee
- \$10 Seasonal Fee — goes toward the league pot
- Fees are charged on week 5 of play.
- Weekly dues: \$10 per player, per week played.
- If a player is already BCA sanctioned elsewhere, notify DVPL so the sanction can be confirmed, and the player is not charged again.
- BCA sanctioning paid during the current calendar year remains valid for the applicable tournament year.

- Remind your players of the fees in advance. After 2 games, the BCA fee is due (\$20 and if not sanctioned). On week 5 of play, the Seasonal and Scorekeeper fees are charged.

1B. Payment & Scoresheet Procedures

- Zelle or Venmo preferred.
- **Captains send one combined team payment and include the breakdown by player; no individual player payments, please**
- If a captain pays with cash, make sure it is clearly written on the score sheet.
- Uncollected player charges are deducted from the team's payout.
- Make sure your scoresheet is filled out completely and email or text it to DVPL after your match.
 - Team number
 - Each round's total should be 60 points between the teams. The final total for all 4 rounds should be 240 (60 points x 4 rounds).

2. LMS / BCA / FARGORATE

- DVPL reports results to FargoRate through LMS. Scores are entered manually (See Open Master Rules #1)
- FargoRate allows players to see their current rating and matches played.
- FargoRate standings and averages will not match DVPL because the scoring systems are different.

3. RULES REVIEW & REMINDERS

3A. Standing Review Items

Handicap: Current rule is 150%.

Blind Limit: Current rule is 7 single blinds and 1 double blind per season.

3B. Important Rule Reminders

We will be releasing our 2026 Master Rules document.

Operator lists only the Master Rules she wants to emphasize for this session, using the new rule reference.

- **Example:** Rule 5A — Start Times, Blinds & Forfeits

Match Start Time: 7:30pm, 7:45pm use a blind

- **Example:** Rule 8A — Submitting Scoresheets

We are once again addressing ongoing unsportsmanlike behavior from a small number of players. Despite repeated discussions, warnings, and financial penalties, the behavior continues. Effective immediately, any player with pending warnings who continues to act in a disruptive, disrespectful, or unsportsmanlike manner may be removed from our league and asked to participate elsewhere. Respect, sportsmanship, and good conduct are not optional. Thank you for helping us maintain a positive environment for all players.

4B. Current Sponsor & Venue Information

- Paddock Bowling Alley and Champion Snooker and Cue N Brew: \$3 per player / \$12 per team for table use, paid at the beginning of the evening.
- Cue 'N Brew will sponsor (2) teams.
- The Office sponsor will have (2) teams

- CJ's and Farrington's each sponsor (2) teams.
- Paddock Bowling Alley has (2) teams, and sponsor fee is being paid by the players
- Sponsor payments are tracked; captains are encouraged to assist DVPL with sponsor communication.

4C. Cue 'N Brew Venue Guidelines

- League tables are made available at 7:00 p.m. (approximately 7:15 by bar clocks). Earlier use requires payment at the current rate.
- No drinks on the tables.
- No writing on the tables, including writing on paper or posters placed on the table.
- Do not sit or lean on the rails.
- Respect customers and communicate with bar staff. League players are not to tell customers that a table is theirs or take pool balls from them.

5. OTHER LEAGUE INFORMATION

5A. Alternates

- The floater-alternate concept continues based on need. Contact DVPL as soon as possible when an alternate is needed.
- An alternate has no financial obligation unless agreed with the captain.
- Alternates may receive an end-of-season payout if they pay the full seasonal dues.
- Full seasonal dues are charged to anyone who plays more than 4 matches.

5B. Half-Time Drinks

- Players must purchase a drink at full price to qualify for the half-time free drink from sponsors that still offer it. Please tip your bartenders.

5C. Captain / League Communication

- League-related information intended for captains should go through the league directors first.

6. END-OF-YEAR TOURNAMENT / PARTY

- End-of-year tournament: blind draw, single-round format, handicap applies.
- \$10 entry per player & \$300 is reserved from the main payout for the tournament.
- **\$10 for table time to the sponsor**
- Non-members attending the end-of-year party pay \$25 for food and raffles.
- **For this year we are going to ask our members to RSVP as we pay for food according to how many players, we expect.**

7. PAYOUTS & LEAGUE INFORMATION

- Payouts are sent to league players for review and comments and revised as necessary.

The DVPL Open/Mix Master Rules are the official rules of league play. Approved standing rule changes will be incorporated into the Master Rules.
